1. I hereby release and discharge HENRY'S HUMBLE HEART and all its officers, employees, representatives, and volunteers from all claims, demands, causes of action of any nature or cause, for any such injury or damage incurred or suffered.
2. I understand that HENRY'S HUMBLE HEART is not responsible for any lost, stolen, or damaged valuables or property.
3. I acknowledge that I have received and read a copy of the current rules and regulations governing my conduct at and away from the facility. I agree that I will fully comply with all rules and regulations including the company safety and fleet policies. I have read the Agreement and understand that by signing the Agreement I have consented to be bound by its terms, including the waiver/release of any legal right I may have to sue HENRY'S HUMBLE HEART for any costs they incur because a claim or legal action is brought in violation of this Agreement.
4. I acknowledge and agree that activities performed will be performed strictly on a voluntary basis, without any pay, compensation, or benefits. I agree and understand that I must comply with the rules and regulations established from time to time by HENRY'S HUMBLE HEART and that failure to do so may result in my immediate removal as a volunteer.
